WELCOME TO CLAUDIA ANDRÉ, ASSISTANT IN URBAN DEVELOPMENT

The municipal council has ratified the recommendation of the managing director and has authorized the hiring of Ms Claudia André to the position of assistant in urban development for the summer. Ms André has been working here since May 8th and is studying for a degree in urban development at Montreal University.

POOLS

Residential pools are an important drowning risk for young children especially if they evade the supervision of an adult and if the installations are not adequately secure. The municipality is responsible for the enforcement of the bylaw on the safety of residential pools. The bylaw applies to all exterior residential pools with a capacity of 60 cm or more of water, whether it be in-ground, partially in-ground, above ground or can be dismantled (inflatable or other) as well as hot tubs of 2000 litres of water (529 gallons US) and more.

A permit for a pool is required for the following works:

- ◆ Construct, install or replace an in-ground pool, partially in-ground, above ground, can be dismantled or for a hot tub with a 2000 litre capacity;
- ◆ Install a diving board;
- ◆ Construct an enclosure, a platform or a deck opening onto a pool.

Here are a few safety norms for pools:

- ◆ **All owners of pools installed before November 1, 2010 have until September 30, 2025 to conform to the bylaw on the safety of residential pools.**
- ◆ **All in-ground, partially in-ground, above ground pools whose height is inferior to 1.2m or can be dismantled whose height is inferior to 1.4 m must be surrounded by a rigid enclosure.** It must be higher than 1.2 m, must stop a 10 cm spherical object and must be without any component that can make it easy to climb;
- ◆ All porches or decks adjacent to a pool must have an enclosure at least 1.2 m high and a door to protect access.
- ◆ The door giving access to the pool must close and lock automatically.
- ◆ Any device used for the heating or filtration of the pool must be installed at a minimum distance of 1 m for an above ground pool or one that can be dismantled except when it is installed inside an enclosure, under a structure that prevents access to the pool from the device, in a shed..

There are no acquired rights in the matter of safety!

SHORT TERM RENTAL IN A RESIDENCE OTHER THAN THE MAIN RESIDENCE

Zoning bylaw 308 allows establishing short term rental as supplementary housing in a residence other than the main residence, under certain conditions. We offer you a slew of information on a file available on our web site under the tab Service aux citoyens / permis. Fees of \$500 are required to obtain an occupation certificate and it is valid for one (1) year starting on the day it is issued. After this date, another occupation certificate must be obtained from the municipality to maintain activities or occupation..

NEW GUIDELINES FOLLOWING THE COMING INTO FORCE OF BYLAW 308-46 MODIFYING THE ZONING BYLAW

Here are some of the new guidelines concerning the zoning bylaw which is in force since last May 10th.:

- ◆ Introduction of norms concerning generators;
- ◆ Introduction of conditions to allow the use of maritime containers as garages and sheds;
- ◆ Introduction of norms concerning laying hens outside the agricultural zone (following the pilot project of 2021);
- ◆ Introduction of norms concerning the use of trailers for recreational purposes on a temporary basis (following the pilot project of 2021);
- ◆ Introduction of norms concerning the use of trailers as housing for agricultural workers on a temporary basis;
- ◆ Removing the maximum height of an hedge in the front setback margin (except for the visibility triangle) and in the lateral and back setback margins (with the exception of the panoramic strip for the lots on the riverside);
- ◆ Introduction of norms requiring that trees be planted when constructing any new main building.

BAN ON THE APPLICATION OF FERTILIZERS AND PESTICIDES

Following the modification of nuisance bylaw 478, to proceed or allow to proceed to the exterior application of fertilizers and pesticides on the shore is now banned except for those exceptions mentioned in the bylaw. Here are some of these exceptions.:

- ◆ Use of pesticides and fertilizers for agricultural uses according to the *Loi sur les producteurs agricoles*, L.R.Q., C.P-28, on the outside of the shore or any water course and at more than 3 metres from the top of the embankment of a ditch.;
- ◆ Indoor extermination
- ◆ Use of pesticides and fertilizers on golf courses;

In all cases, application of fertilizers and pesticides must always respect the government norms in environmental matters..

Public Works

PROHIBITED MATERIALS

It is prohibited to dispose, among others, of materials from construction or renovation work, of tires, biomedical waste, dead animals, toxic waste, manure and sludge of all kinds, of ashes, cement, bricks and stones. These materials will not be picked up and must be brought to the dry material waste site. If in doubt, please consult the list on our web site or contact the director of public works, Gabriel Trevino, by phone at 450 264-4302, or by e-mail at gtrevino@stanicet.com

DRY MATERIAL WASTE SITE (PASS NUMBER MANDATORY)

For 2023, each property is given **ONE free pass** for the dry material waste site. This pass is **valid for a trailer 4' x 8' or the box of a pick-up truck**. To use this service you must call the Town Hall, send an e-mail to communication@stanicet.com or make a request on line via the Voilà portal

*****OPEN ONLY ON THE 1ST AND 3RD SATURDAY OF EACH MONTH FROM 8 AM TO NOON (except in July, open on July 8 and 22)**

Fire Department

To reduce the risks of fires and injuries from fires at the cottage, follow the following recommendations from the fire department:

- Check smoke and CO detectors once a month or each time you return to the cottage.
- Clean barbecues before using and keep an eye on it when it is in use. An unattended barbecue can cause a fire.
- Keep lighters, matches and barbecue lighter out of sight and out of reach of children.
- Don't forget to bring a flashlight with spare batteries.
- Check heating apparatus and chimney flues before using them.
- Check with your municipality or on the sopfeu.qc.ca web page if outdoor campfires are authorized before lighting one or before burning brush. Always have a pail of water, sand or even a shovel nearby and never leave the fire unattended.
- Smoke outdoors and keep a large metal box full of water nearby to throw in butts safely.
- It is recommended that organized public fireworks are preferable to family fireworks. If you do so, you must obtain a permit from the municipality.

This caravan will offer the possibility to have well water analysed at a reduced price. It will also be possible to question professionals on the maintenance and functioning of a well in relation with the environment.

The cost of analysis that we offer during this Caravan is the Following:

	<u>Analysis parameters</u>	<u>Caravan price</u>
Basic test (potability)	Total and fecal coliforms as well as atypical bacteria	\$ 40 (tax included)
Advanced test (Potability + ions in solution)	Total and fecal coliforms, Atypical bacteria, Alkalinity, conductivity, pH, iron, manganese, cloudiness and total hardness	\$ 95 (tax included)

Boxes containing sterilized bottles will be available on site, 2 weeks before the event

En contrepartie, la Loi prévoit les mesures suivantes : Le maire doit lors de la séance ordinaire du conseil tenue en juin, faire rapport aux citoyens des faits saillants du rapport financier et du rapport de l'auditeur indépendant. Tout d'abord, j'ai le plaisir de vous présenter le rapport sur les faits saillants de l'exercice financier 2022. Les états financiers démontrent que nous avons dégagé un surplus consolidé de 149 559\$ pour l'année 2022, résultat d'une saine gestion et d'un contrôle rigoureux des finances publiques. Ces résultats positifs sont notamment attribuables au développement de notre Municipalité et un marché immobilier très actif qui a engendré des revenus supplémentaires en matière de droits de mutation. D'autre part, des économies ont été réalisées au niveau des dépenses, principalement aux activités de loisirs, au déneigement et aux parcs.

L'année qui s'est terminée le 31 décembre 2022, les revenus de la Municipalité se sont chiffrés à 6 365 600\$ alors que les charges s'élevaient à 5 771 626\$, ce qui nous a amenés à un excédent de l'exercice de 593 974\$ avant conciliation à des fins fiscales. Une fois cette conciliation effectuée, nous obtenons un excédent de 137 448\$.

-  Revenus de fonctionnement additionnels nets de 244 176 \$
-  Excédent du rapport financier consolidé 149 559 \$
-  Augmentation de la dette à l'ensemble des contribuables de la Municipalité pour 2022 de: 797 109 \$

À la fin de l'exercice financier 2022, la dette à long terme consolidée de la Municipalité était de 3 356 210 \$. Incluant les revenus futurs découlant des ententes conclues avec le Gouvernement du Québec.

Rapport de l'auditeur indépendant BCGO s.e.n.c.r.l. les états financiers consolidés donnent, dans tous les aspects significatifs, une image fidèle de la situation financière de la Municipalité de Saint-Anicet et des organismes partenaires, ainsi que des résultats de ses activités, de la variation de ses actifs financiers nets (sa dette nette) et de ses flux de trésorerie consolidés.

Rapport de l'auditeur indépendant

De l'avis des auditeurs, les états financiers consolidés donnent, dans tous leurs aspects significatifs, une image fidèle de la situation financière de la Municipalité de Saint-Anicet au 31 décembre 2022 ainsi que des résultats de ses activités, de la variation de ses actifs financiers nets (de sa dette nette) et de ses flux de trésorerie pour l'exercice terminé à cette date, conformément aux normes comptables canadiennes pour le secteur public.

La firme BCGO. s.e.n.c.r.l. a été retenu pour l'audit obligatoire des comptes de la Municipalité, tenus par le directeur général et greffier-trésorier, en vertu du Code municipal de la province de Québec.

Constatations découlant de l'audit

Dans son rapport pour l'exercice qui se terminait le 31 décembre 2022, l'auditeur BCGO s.e.n.c.r.l. a relevé les faiblesses suivantes dans la conception ou la mise en œuvre du contrôle interne à l'égard de l'information financière.

-  L'opinion de l'auditeur soulève une réserve concernant l'exhaustivité des droits des carrières et sablières, puisque nous n'avons pas mis en place des mesures pour nous assurer de l'exactitude des déclarations produites par les exploitants

RÉALISATIONS 2022

Pour que la gouvernance municipale soit transparente, légitime et crédible, une organisation municipale se doit d'informer ses citoyens de son fonctionnement et de la performance de ses différents services.



Project to characterize the quality of the water on the south bank of the lake

The ASLSF has just concluded a contract in the amount of \$20,000 to retain the services of the Zone d'Intervention Prioritaire (ZIP) du Haut-Saint-Laurent to realize a project to characterize the quality of the water on the south bank of the lake. This project covers 10 sites on the bank, from Dundee to Saint-Stanislas-de-Kostka, which will be sampled 12 times during the summer.

These samples aim to create an objective data bank to support the steps of the ASLSF in our approach to the agencies responsible for water management on the territory, among others, the MRC's, the municipalities of the MRC's as well as the provincial, and federal departments that are responsible for this matter. This will allow for an objective data bank that will be a very important tool to better identify the sources of the problems and to find the appropriate means to correct them.
