Watercourses / Maintenance

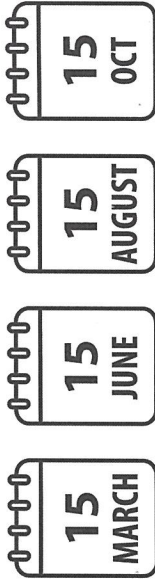
The expected expenses regarding the maintenance of watercourses are billed to taxable properties, located in an agricultural zone.

Sectorial taxes / Private Road maintenance / Asphalt

Depending on your property, sectorial taxes can be charged.

DID YOU KNOW ? Arrears, credit balances and postdated cheques appear on your tax bill.

If the total taxes and compensations of a tax bill is \$ 300 or more, this bill is payable in 4 installments, otherwise the total amount is due on March 15th.



PAYMENT MODE

ATM, over the counter or on the Internet platform of your financial institution. Our organization name is Municipalité de Saint-Anicet. Reference number = roll number beginning with the letter D or F. Depending on the financial institution, the number of characters to be entered may vary (alphanumeric of not, from 10 to 17 digits). If you have multiple accounts, you must make one payment per account. The Municipality is not responsible for any delay in the processing of your payment by financial institutions

Provide us with your postdated cheques with the coupons by the due dates. Please write your roll number on the back of your cheque. Do not staple the coupon to the cheque
